The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the Ministries of Foreign Affairs of the IAEA's Member States and has the honour to request that they draw the attention of the appropriate governmental authorities to the **International Conference on Clinical PET–CT and Molecular Imaging: PET–CT in the Era of Multimodality Imaging and Image Guided Therapy (IPET-2015)** to be held at the IAEA's Headquarters in Vienna, Austria, from **5 to 9 October 2015**.

The purpose of the conference is to provide clinicians, scientists and professionals with an international forum at which they can review the latest developments in all aspects of clinical positron emission tomography (PET), positron emission tomography–computed tomography (PET–CT) and molecular imaging, with a view to addressing the health challenges common to many IAEA Member States.

The conference will be held in English.

The Secretariat would be grateful if the attached Announcement and Call for Papers, as well as the accompanying forms, could be brought to the attention of the competent national authorities, institutions and individual experts that might be interested in participating and submitting papers on the topics listed in Section C of the Announcement and Call for Papers. Member States are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the conference. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Such assistance may be offered upon specific request to normally one participant per country provided that, in the IAEA's view, the participant on whose behalf assistance is requested will make an important contribution to the conference. The application for financial support should be made at the time of designating the participant in accordance with the procedure described in Section H of the Announcement and Call for Papers.

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in meetings, workshops or training courses or for consultants. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

Governments are requested to inform the designated participants that, if they require a visa to enter Austria, they should submit the necessary application to the nearest diplomatic or consular representative of Austria as soon as possible.

The Secretariat of the International Atomic Energy Agency avails itself of this opportunity to assure the Ministries of Foreign Affairs of the IAEA's Member States of its highest consideration.
